

Restricted Items

Under our terms and conditions we list certain items that should not be offered for international transit and storage. These excluded items include items which may be considered hazardous, a bio security hazard at destination, attract vermin or infestations, or be of interest to third parties with a criminal intent.

We have summarised the categorises' of Excluded Items as a reminder for you, in advance of the collection of your goods for international removal, to make alternative arrangements for such items and to ensure these items are not offered for transit or storage.

By Air or Courier



NO LIQUIDS

Any cosmetics/ varnish/ lipstick/ mascara/ cream/ gels/ waxes/ tooth paste/ spirit levels/ clays



NO AEROSOLS

Gasses/ deodorant/ paint/ hairspray/ cigarette lighters/ gas canisters



NO FOOD

Any food / drink related items including tea bags/ coffee/ dried food/ spices/ powdered formulas



NO KNIVES Knives/ tools/ ice picks/



NO BARS OF

SOAP



NO BATTERIES

All batteries including mobile phones/ tablets/ cameras/ battery operated toys/ remote controls



NO VAPE Tobacco products/ any type of electronic cigarette



NO CANDLES OR WAX



NO PILLS

Any pills/ tablets/ capsules/ any type of prescription medication



NO PRINTER CARTRIDGES

Any package by air or sea containing a prohibited item will be subject to a surcharge of £30 and the items will be removed and destroyed and may delay air or shipment dispatch.



By Sea

Some items that are prohibited by air can be taken by sea:



NO AEROSOLS

Gasses/ deodorant/ paint/ hairspray/ cigarette lighters/ gas canisters



NO CORROSIVES

Dishwasher/ washing powder/ tablets/ solvents/ metal or wood polish/ radioactive materials



NO WEAPONS

Unless prior agreement/ crossbows/ guns/ knives (except kitchen)/ ammunition



NO FLAMMABLES

Matches/ lighters/ vapes/ Christmas crackers/ cooking oil/ diesel/ nail polish remover



NO CHEMICALS

Poisons/ weed killer/ bleach/ white spirit/ Ammonia/drain cleansers/ air fresheners



NO BATTERIES

Batteries including mobile phones/ tablets/ cameras/ battery operated toys/ remote controls



NO PAINT

Including household or exterior paint of any kind/ creosote/ fence paint/ nail paint



Walkie Talkies/ short band radios/ drones/ wireless phones



Restricted Items

Certain items cannot be imported as personal effects into certain countries or may be subject to inspection and/or treatment or obtaining an import license.

Restricted items are noted below:



ALCOHOL OR TOBACCO

Importation of alcohol is prohibited in the USA



BIRDS AND INSECTS



AGRICULTURAL, DAIRY OR MEAT PRODUCTS



SADDLES OR RIDING EQUIPMENT



STRAW HANDCRAFTS OR PACKAGING



WOODEN ARTICLES, CANE, BAMBOO, BASKET WARE, MATS OR WOOD PACKAGING



DRIED FLOWERS, HERBS, MEDICINES, PLANTS, SEEDS ETC



BONES OR SHELL ARTICLES



FOOD ITEMS



VEHICLES, CARS, MOTORBIKES, CARAVANS, SEGWAYS ETC



ANIMALS, ANIMAL HAIR OR WOOL



PRESCRIPTION AND SOME OTHER DRUGS



ANIMAL PRODUCTS, IVORY, FUR, REMAINS



FIREARMS, SWITCH BLADES, BAYONET'S OR SWORDS



PORNOGRAPHIC MATERIAL OR ITEMS WHICH COULD CAUSE OFFENCE
